- **Beechwood Cemetery:** Supervisor explained the Beechwood Cemetery Association Board is down to one surviving member. The Town Board is helping them create a new Board, so it does not become an abandoned cemetery which the Town would have to take over.. There is a public meeting for lot owners on February 15, 2023, at 6:00P.M. Supervisor Entwistle is accepting nominations until February 10th by mail or email. If there are not enough lot owners to vote, the Town Board will appoint the Trustees for the first year.
- Master Plan: The Town has received the signed contract from the Department of State. The Master Plan Committee will be choosing a Consulting Company for marketing for every property owner, not just residents. Supervisor Entwistle stated the key piece is making sure everyone responds. As they move along with the Master Plan process, there will be informational meetings for the public. The Town has received a \$30,000 grant towards consultants and mailings.

NEW BUSINESS BOARD:

• **Forestport Fire Cancer Insurance:** Supervisor Entwistle read a letter aloud from Mr. Schuler asking the town to cover half of their cancer insurance in the amount of \$720.00.

A motion was made by Councilman Scouten and seconded by Councilwoman Verschneider to pay half of the Forestport Fire Cancer insurance in the amount of \$720.00.

- **Planning Board Vacancy:** There is an ad advertised in the Boonville Herald for a Planning Board seat. The deadline is February 6th. Supervisor Entwistle has received two applications.
- **SRL/Fee Schedule Updates:** Supervisor Entwistle stated there is a minor change to the fee schedule that he is in discussion with the Planning Board about.
- Local Law: There is a State Law to provide a tax exemption to Firefighters and Ambulance workers. Supervisor Entwistle went over the stipulations. Someone from the gallery asked if they have an irrevocable trust if they are eligible. Another question asked was, if they get the tax credit, can they also receive the tax exemption. Supervisor Entwistle will be asking the Attorney.

Local Law No. 1 of 2023 A Local Law Repealing Local Law No. 1 of 2005 and Enacting a Property Tax Exemption for Volunteer Firefighters and Ambulance Workers Pursuant to Section 466-1 of the Real Property Tax Law of the Code of Town of Forestport

Section 1. Local Law No. 1 of 2023 of the Code of the Town of Forestport, entitled "Volunteer Firefighters and Ambulance Workers Exemption", is hereby enacted pursuant to Real Property Tax Law Section 466-a, to read as follows:

Volunteer Firefighters and Ambulance Workers Exemption

Grant of Exemption.

An exemption of 10% of assessed value of property owned by an enrolled member as set forth below, or such enrolled member and their spouse, is hereby granted from taxation with respect to the real property taxes of Town of Forestport as long as eligibility requirements are met.

Eligibility Requirements.

Such exemption shall be granted to an enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service provider that:

A. The property is owned by the volunteer firefighter or volunteer ambulance worker;
B. The property is the primary residence of the volunteer firefighter for volunteer ambulance worker;
C. The property is used exclusively for residential purposes;
D. The volunteer firefighter or volunteer ambulance worker resides in the Town of Forestport and the Town of Forestport is served by such incorporated volunteer fire company or fire department or incorporated voluntary ambulance services:

E. The volunteer firefighter or volunteer ambulance worker is certified by the authority having jurisdiction as an enrolled member of such an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service; and

F. The volunteer firefighter or volunteer ambulance worker meets the minimum service requirement established by the Town of Forestport which is hereby established as 5 years.

Application.

A volunteer firefighter or volunteer ambulance worker must annually, on or before the applicable taxable status date, file an application for such property tax exemption with the assessor responsible for preparing the assessment roll for the Town of Forestport, on a form as prescribed by the New York State Commissioner of Taxation and Finance. The Town of Forestport must maintain written guidelines, available upon request, as to the requirements of an enrolled volunteer member relating to this exemption.

Certification.

The volunteer fire and volunteer ambulance department must annually file with the assessor, prior to the applicable taxable status date, a list of the active volunteer members who are certified to meet the minimum service requirement. Such list must provide, as of the applicable tax status date, the number of vears of service served by each such enrolled member and such enrolled member's address of residence.

No diminution of benefits.

An applicant who is receiving any benefit pursuant to Article 4 of the Real Property Tax Law as of the effective date of this article shall not have any of those benefits diminished because of this article

Grant of lifetime exemption.

Any eligible enrolled member who accrues more than 20 years of active volunteer service (as certified by the authority having jurisdiction) shall be granted the 10% exemption as authorized by this article for the remainder of his or her life as long as his or her primary residence is located within the Town of Forestport.

Un-remarried spouse of enrolled member killed in the line of duty. The un-remarried surviving spouse of a deceased enrolled member killed in the line of duty, as certified by the authority having jurisdiction, is qualified to continue to receive an exemption, as long as the deceased volunteer had been an enrolled member for at least 5 years and had been receiving the exemption at the time of his or her death.

Un-remarried spouse of deceased enrolled member. The un-remarried surviving spouse of a deceased enrolled member, as certified by the authority having jurisdiction, is qualified to continue to receive an exemption, as long as the deceased volunteer had been an enrolled member for at least 20 years and the deceased volunteer and un-remarried spouse had been receiving the exemption at the time of his or hear death.

Section 2. This Local Law shall repeal a Resolution, dated March 13, 2006, regarding exemption, and replace it with this Local Law.

Section 3. If any clause, sentence, paragraph, section or part of this Local Law is declared by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to said clause, sentence, paragraph, section or part of this Local Law.

Section 4. This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Municipal Home Rule Law Section 27.

A motion was made by Councilman Scouten and seconded by Councilwoman Kardash to schedule a Public Hearing regarding Local Law #1 of 2023, on March 15, 2023, at 6:15P.M.

- A woman from the gallery stated she and her husband are on the corner of North Lake Road and Kincaid Road and Tony suggested she attend the Board meeting to ask permission to have chickens and pigs with a farmstand. Supervisor Entwistle

told her she would have to follow Cornell's guidelines and there would need to be fencing. If it is a little stand on the honor system, there are no issues.
